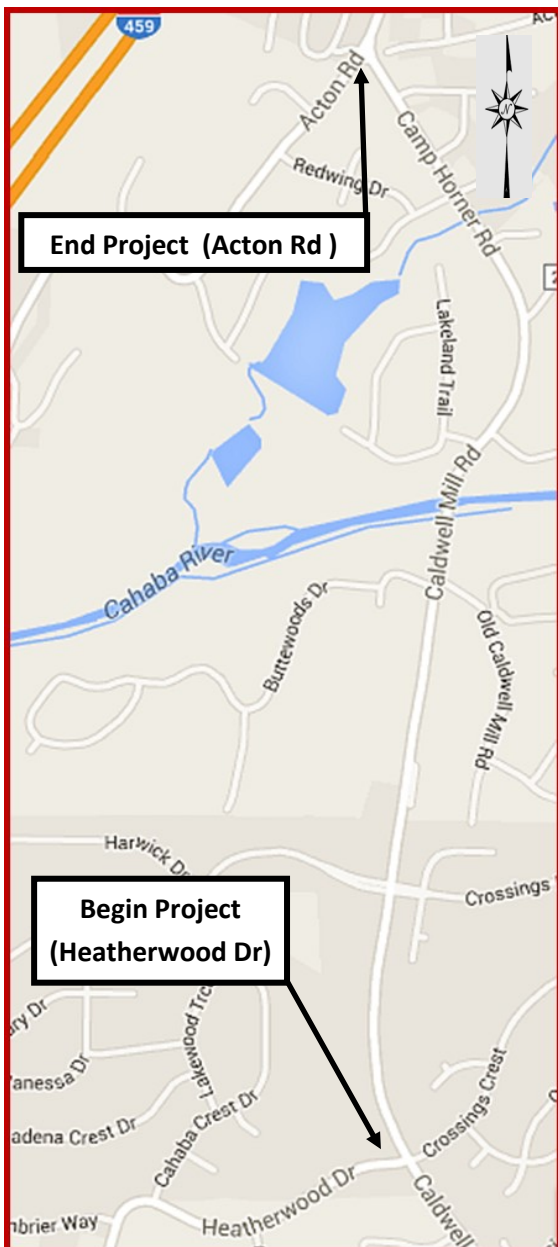

ENVIRONMENTAL ASSESSMENT IS AVAILABLE FOR REVIEW
WIDEN CALDWELL MILL ROAD (CAMP HORNER ROAD)
FROM HEATHERWOOD DR TO ACTON RD AND REPLACE BRIDGE OVER CAHABA RIVER
PROJECT NUMBER: STPBH-5939(200)

The Alabama Department of Transportation (ALDOT) with Jefferson and Shelby Counties are proposing roadway improvements on Caldwell Mill Rd/Camp Horner Rd. This notice advises the public that an Environmental Assessment (EA) for the proposed project is available for public review and comment. The EA provides information on the potential impacts to the natural and human environment. Your comments may be provided by mail, email, or voicemail as described below. Your comments on the proposed project document must be **submitted by Friday, August 7, 2020**.



Project Description: The proposed project is located in Shelby and Jefferson Counties. The project begins south of the Heatherwood Drive/Crossings Crest intersection in Shelby County and extends to the Intersection at Acton Road in Jefferson County. The length of the project is approximately 1.5 miles. The proposed widening and improvements of Caldwell Mill Road/Camp Horner Road (CR-29/CR-1277) would provide a 3-lane roadway, (1 lane in each direction and a center 2-way left turn lane) and sidewalk on the east side of the roadway. The existing bridge over the Cahaba River will be replaced. Right-of-way acquisition is required.

WIDEN CR-29(CALDWELL MILL ROAD) FROM HEATHERWOOD DRIVE TO ACTON ROAD AND BRIDGE REPLACEMENT OVER THE CAHABA RIVER

PROJECT NUMBER: STPBH-5939(200)



The purpose of this project is to improve existing roadway deficiencies – including the vertical and horizontal alignment, and bridge structure. Once completed, CR-29 will be a three-lane facility from SR-119 (Cahaba Valley Road), crossing CR-17 (Valleydale Road) to Acton Road with bridge replacement.

Project Description: The proposed project is located in Shelby and Jefferson Counties. The project begins approximately 560 ft. south of Heatherwood Drive/Crossings Crest intersection in Shelby County extending to the T-Intersection at Acton Road in Jefferson County. The length of the project is approximately 1.6 miles. The existing roadway is a two-lane section; the proposed widening and improvements of CR-29/Camp Horner Road (Caldwell Mill Road) would provide a 3-lane section, two through lanes, a center continuous two-way left turn lane and sidewalk on the west side of the roadway. The existing 225 ft. bridge over the Cahaba River will be widened to 62.5 feet, realigned and lengthened to approximately 460 ft. The bridge section will include 2 through lanes, shoulders and sidewalk. Right-of-way acquisition is required.
