A Report to the Voters of Jefferson County from Barry K. Stephenson, Chairperson Board of Registrars

Please check the list on page 2 to find your voting location. If you fail to find your name on the list, please check with the Board of Registrars at 325-5550 immediately. Locations where you may find a form to register or update your address are listed on page 2.

You should vote where your name is on the list. Please update your record now to avoid <u>any</u> problems at the polls on Election Day.

In order to ensure voters' rights, the Federal "Help America Vote Act" and the Alabama Election Code provide for "provisional voting". Provisional voting was created to allow a voter, whose eligibility has been questioned, to vote on Election Day.

If a voter's name does not appear on the list of registered voters, the provisional officer must call the Board of Registrars to verify the correct voting location, ballot and the voter's eligibility to cast a ballot. The provisional officer will be informed of the voter's correct voting location, ballot and eligibility to vote and relay this information to the voter. A voter who disputes this information will still be allowed to vote. However, if the voting place or ballot is not correct for the voter, it will not be counted. The voter has until the close of business on the Friday following the election to present their evidence to the Board of Registrars to allow that ballot to be counted.
