## **Accumulated Leave Conversion**

### 1.0 PURPOSE

Jefferson County recognizes when employees achieve a healthy balance between work and personal life, then the business benefits. As such, the purpose of this Rule is to support Jefferson County employees' work life balance. Jefferson County Commission approves and provides employees with regularly scheduled holidays, a variable holiday, and vacation leave and sick leave according to Rules 13.9 and 13.10 of the Personnel Board of Jefferson County Rules and Regulations, which establish applicable accrual schedules. This Rule provides employees with the option to convert up to forty (40) hours of accumulated sick leave to vacation leave in any fiscal calendar year.

#### 2.0 **RULE**

- Jefferson County employees who have completed 12-months of uninterrupted paid service with the County may opt to convert up to forty (40) hours of accumulated sick leave to vacation leave annually.
- Conversion will decrease an employee's sick leave accumulation by the amount converted and increase the employee's vacation accrual balance by the same amount.
- To participate, employees must have a minimum of one hundred and sixty (160) hours of accumulated sick time of conversion.
- The election period will occur at a time designated by the County Manager.
- Election cannot occur outside of the established election period.
- Once an election is made, it is non-revocable.
- Vacation conversion does not increase the vacation carry-over maximum of 320 hours annually.
- As policy requires, all vacation, including vacation conversion days, must be scheduled with employees' supervisors.



Jefferson County employees requesting to participate must complete and submit to the Human Resources Department – Payroll Division an *Accumulated Leave Conversion Election Form* (Figure 1) no later than close of business on the last day of the published election period.
